#### Describe your plans and career goals upon graduation.

After graduating with my Juris Doctor degree, I plan to enter the field of agricultural policy and succession planning. The reality is that protein production isn't based on buzzwords and trending social media posts; instead, putting meat into the mouths of the world's inhabitants depends on the passion and sweat of dedicated farmers who come in all shapes and sizes.

My mission is to be an educated and fact-based voice for agriculture. My goal has been to provide accurate and unbiased information to those not involved in agricultural production and to assist producers in equipping themselves with the knowledge and skills necessary to thrive. This goal has motivated me to further my education and acquire additional tools to enhance my capabilities as a reliable information source. While I have known for some time that I wanted to pursue my passion for upholding the agricultural way of life, I also recognized that I needed a diverse skill set, as today's agriculturalists wear many different hats. #### Describe what activities have been most meaningful to your personal development.

The first is my involvement in junior livestock associations, which impacted many facets of my life. My presentation skills and competitive mindset can be traced back to my years in these organizations. The events and opportunities afforded to me as a junior member undoubtedly made me a better and more effective communicator. This has opened many opportunities for me in both professional and social settings. My jobs are directly attributed to the skill set I developed as a youth, and nearly all of my mentors and current peer group are livestock enthusiasts. All of these people and experiences shaped who I have become.

The breed organizations also introduced me to competitive livestock judging, which was the second activity that had a significant impact on my personal development. To put into words the effect livestock judging has had on my life is nearly impossible. I have been fortunate enough to judge livestock competitively for most of my life and was able to pursue my passion in college. I learned decision-making skills, public speaking, networking, and evaluation. I was conditioned to find the positives and negatives in livestock and weigh these advantages against one another. Judging taught me decision-making skills. When giving reasons, I learned to convey my opinion correctly. Learning to communicate effectively has impacted how I interact in the workforce. I can accurately convey my opinion and learn from judging to stand by it, even when it's not popular. Judging also opened my eyes to the diversity and vastness of the livestock industry, allowing me to travel the country and interact with a wide range of producers.

Ultimately, it was my background in livestock that led me to cross paths with WYXY Classic. When I started my internship with WYXY, I had little knowledge of the radio industry and the technical aspects of creating a farm show. Initially, the only thing I had going for me was that I enjoyed talking and had some knowledge of several different areas of agriculture. Life came full circle years after my first interview with Gale, as he became my mentor. The most significant impact was when I delved deeply into reporting on the commodity markets and developed a passion for learning more about marketing. I was enthralled with the fast-moving pace of reporting the markets and farmers calling in to discuss why the markets were up or down.
