Describe your plans and career goals upon graduation.

After graduating with my agricultural science degree from Cornell University, I aim to continue covering news, whether in the American agriculture industry or the global food system.

I enjoy writing, investigating events and situations, and using digital media to communicate the advancement and progress of the agri-food sector. I would particularly enjoy covering agriculture policy in Washington, D.C., and being a part of a TV broadcast team. Many sectors in agriculture have yet to tell their stories to the fullest capacity - through storytelling and science communication. Accurate and balanced news coverage is needed now more than ever as First Amendment rights and journalism are under attack around the world.

In the last year, I have covered international stories while living abroad and have found a great need and opportunity for reporting on global trade, politics, and agriculture as our current trade partners are shifting. If an opportunity to work and write abroad arose, like I did for half a year in 2025, I would consider this path, continuing to freelance. There are

many components of learning that I hope to incorporate into my career: media marketing, foreign languages, storytelling, and increasing access to public media. Agriculture is the perfect market to achieve these goals.

One day, I hope to return to a farm of my own, putting years of knowledge and advocacy into practice. Until then, my goal is to equip the food system with the knowledge and news needed to transform it.

Describe what activities have been most meaningful to your personal development.

Several activities recently have been most meaningful to my personal development.

Immersing myself in international agriculture, I believe, was a crucial step in truly understanding our food system. Farm broadcasters' audiences are American farmers, yes - but our work should also be about understanding the movers and shakers around the world. If agriculture says, "we feed the world," let's report on the world. From January to July of this year, I lived in Europe for a semester of school in Vienna, Austria, and also spent a few months traveling to over 12 countries to speak. I spent that time with farmers, shippers, rural residents, and government officials. Some interesting environments I found myself in included the halls of the European Parliament in Brussels, joining foreign press groups, befriending journalists from 20-plus countries, asking hard questions, and hearing about the positive and consequential decisions made in the U.S. and their impact abroad.

Freelancing as a journalist has been an extremely valuable experience to learn about the news and publishing industry. From different writing styles to pitching processes, it continues to challenge me professionally, working in a competitive, creative world. Since finishing my Agri-Pulse internship in Washington, D.C. last summer, I have been able to take political reporting and general feature writing to other publications across the country. It has given me the flexibility to cover stories that interest me and to pursue a life of adventure that involves writing about those experiences. In Ohio, I write for Ohio Country Journal, The Springfield Hub, The Toledo Blade, and Farm & Dairy. Nationally, I highlight topics I think deserve more attention in AgDaily and Agri-Pulse. Internationally, my work can be found in Melk de Langs, a Netherlands dairy magazine.

This year, I started a blog on Substack, an opportunity to continue reporting and writing opinion pieces on issues I think are important in the world. The page, called Glasshaus, is all about the heat of politics, life under glass, and the shared economy of people and nature - food and agriculture. From travel to food, news to opinion, I connect with people who want to hear my thoughts. One day, I hope a writing platform like this could grow into a real publication. Daily writing has been valuable in improving my skill.

School is a privilege for me. I always find it fascinating how the most eager learners and seasoned thought leaders meet in the middle - in the form of a classroom. My education has provided flexibility to follow my dream and an avenue to pursue almost every idea that has popped into my head. Admittedly, I took many risks to pursue new paths that had never been achieved at my educational institution, but change requires pathfinders. Industry conferences during school semesters have been a successful part of my career, especially NAFB. Because I work and study agricultural communications in the Northeast quite independently, it has been extremely valuable for me to connect with communicators in Kansas City.

Academic Calendar – Cornell University operates on a semester calendar consisting of standard fall and spring semesters, and with summer and winter sessions of varying lengths.

Accreditation – Cornell University is accredited by the Middle States Commission on Higher Education (MSCHE) as a degree-granting institution at the baccalaureate, master's, professional, and doctoral levels. Various departments and programs within the University are also accredited by various agencies. Detailed information about these agencies and the accreditation process is available from the Dean's office of each academic unit.

Class Rank - Cornell University does not calculate or support a class rank for students.

Course Titles and Descriptions – Full course titles and course descriptions are provided in the Courses of Study/Catalog.

Credit Hour Definition – Credits are equal to semester hours. One credit is equal to one semester hour. A student will receive one credit by satisfactorily completing a course that requires at least fifteen hours (15) of instruction and at least thirty hours (30) of supplementary assignments. Hours are adjusted proportionately for the other formats of study, e.g., laboratory, studio, research, problem-based learning, and independent study. Winter and summer session courses and study abroad experiences vary in length but are reported in semester hours.

Dean's List – Posting the Dean's List notation began with the Fall 1971 term. Dean's List awards are posted for most undergraduate schools/colleges.

Definition of an Official Transcript – An official transcript is one that has been received directly from the issuing institution. It must bear the University seal, date, and signature of the university registrar. A transcript received that does not meet these requirements should not be considered official.

Degrees and Credit Awarded by Other Institutions – Any information displayed reflecting degrees awarded by, or transfer work accepted from, other institutions should be verified with the original institution for convergence.

Grade Point Average (GPA) – The GPA is computed by dividing the total grade points by the total of credithours in which grade points were recorded. GPAs are displayed to three decimal places. Courses taken at external institutions are not included in the Cornell University GPA. Coursework in graduate school and law careers do not include a calculated cumulative GPA. If a student has enrollment in multiple career levels, the cumulative GPA is associated with credits completed at each respective career level.

Issuing Campus for Transcripts – Each campus has the authority to produce and issue a complete transcript that contains all courses attempted. Official transcripts may be issued from Cornell University in Ithaca, New York; from Weill Cornell Medicine in New York, New York; or from Weill Cornell Medicine in Doha, Qatar. Official transcripts include the complete academic record of all credit-based courses taken at the respective campuses indicated above, which may include undergraduate, graduate, professional, and/or non-degree coursework.

Language - All courses are taught in English with the exception of certain language courses.

Leave of Absence/Withdrawal - Students may request a voluntary Leave of Absence (LOA), or a college may place a student on a leave of absence or withdraw a student from the University at their own discretion. A notation regarding the leave of absence/withdrawal is included within the academic term of the leave.

Median Grade – Median grades were posted on transcripts for all undergraduates enrolled Fall 2008 – Spring 2023. Median grades were not reported for all courses.
