



President The Russell Group

Randy Russell was born and raised in Virginia. Prior to joining The Russell Group in 1986, Russell served in a number of agricultural policy positions, both inside and outside of government, including chief of staff for Secretary of Agriculture John R. Block, deputy assistant secretary for economics at the

United States Department of Agriculture (USDA), vice president for agriculture and trade policy at the National Council of Farmer Cooperatives, director of government relations for The Pillsbury Company, and 1981 Farm Bill coordinator for the USDA. Russell also served on the Senate agriculture committee staff for former Senator Rudy Boschwitz (R-MN). Russell attended George Mason University (GMU), where he conducted both his undergraduate studies in public administration and graduate studies in economics. He is a proud alumni member of GMU's baseball team, where he played catcher.

Randy currently serves as chairman of the board and is on the executive committee for the World Food Program USA, which raises awareness and funding to fight hunger around the globe. The World Food Program recently was awarded the Nobel Peace Prize for its work addressing global hunger. Russell also has been actively involved in the Big Brothers/Big Sisters Program in northern Virginia; he was a Big Brother for ten years and was named president, vice president, and treasurer of the Northern Virginia Council of Big Brothers/Big Sisters and served on the board of Big Brothers/Big Sisters of the National Capital Area. Russell also serves on the board of governors of the Bryce Harlow Foundation, encouraging the highest standards for professional lobbying and government affairs, and he has and continues to serve as a mentor for fellowship recipients interested in going into advocacy.

Russell and his wife, Beth, live in McLean, Virginia, and have six children. The Russells are co-founders of The Golden Phoenix Foundation, working to address the issue of childhood abandonment around the world. He and Beth also are active members of the National Council for Adoption, which helps promote domestic and foreign adoptions as well as foster care. Additionally, the couple has a small farm in Round Hill, Virginia, where they raise alpacas as well as an assortment of other animals.



Secretary of Transportation

Pete Buttigieg currently serves as the 19th United States secretary of transportation, having been sworn in February 3, 2021.

Prior to joining the Biden-Harris Administration, Secretary Buttigieg served two terms as mayor of his hometown of South Bend, Indiana. A graduate of Harvard University and a Rhodes Scholar at Oxford, Buttigieg served

for seven years as an officer in the U.S. Navy Reserve, taking a leave of absence from the mayor's office for a deployment to Afghanistan in 2014.

He returned to the Midwest after school, worked in the private sector, and was elected mayor of South Bend in 2011 with a focus on delivering a new future for the city through a fresh approach to politics and bold ideas.

His leadership helped spark citywide job growth and facilitated innovative public-private partnerships like Commuters Trust, a benefits program designed to improve the city's transportation experience for workers.

In 2019, he launched his historic campaign for president. Throughout 2020, he campaigned for the election of the Biden-Harris ticket and served on the advisory board for the presidential transition. In December, he was nominated by President-Elect Biden to be secretary of transportation. He was confirmed by the Senate on February 2, 2021, becoming the first openly gay person confirmed to serve in a president's cabinet.

Secretary Buttigieg lives with his husband Chasten, their two children Joseph and Penelope, and their two dogs.

Hubert Hamer Administrator

Administrator National Agricultural Statistics Service

Hubert Hamer has served as the National Agricultural Statistics Service (NASS) administrator since 2016. He brings extensive experience in all aspects of the agency's work. Before becoming administrator, he served as director of the statistics division, which produces and releases more than

400 national statistical reports each year covering the agency's crops, livestock, economic, demographic, environmental, and census programs. He also served as executive director of the NASS Agricultural Statistics Board (ASB) and executive director of the advisory committee on agriculture statistics. From 2010 until he became head of the statistics division, Hamer was chair of the ASB, leading the preparation and dissemination of market-sensitive reports compiled and issued under special security conditions known as Lockup. Since joining NASS, Hamer has served in a number of capacities in Washington, D.C., as well as the Louisiana, Illinois, and Missouri field offices. Hamer was born on a small livestock and row-crop farm in Benton County, Mississippi, and later continued his development in Grand Junction, Tennessee. He is a graduate of Tennessee State University.

Coalition, including work on the 2018 Farm Bill. Charney holds a bachelor's degree from Vassar College, a master's in food & agriculture Policy from the Friedman School of Nutrition Science and Policy at Tufts University, and a master's in public health, also from Tufts University.

environmental issues in rural America. In 2020, Bonnie also worked with the Bipartisan Policy Center on its Farm and Forest Carbon Solutions Initiative. Bonnie was under secretary for Natural Resources and Environment at USDA from 2013 to 2017, and a senior advisor to Secretary Tom Vilsack from 2009 to 2013. Prior to joining USDA, Robert was vice president for land conservation at Environmental Defense Fund where he focused on developing incentives to reward stewardship on private lands. Robert has master's degrees from Duke in forestry and environmental management. He lives with his wife, Julie, and daughter, Lilly, in Loudoun County, Virginia.

Secretary of Agriculture

Thomas J. Vilsack was confirmed as the 32nd United States secretary of agriculture on February 23, 2021, by the U.S. Senate. He was nominated by President Joe Biden to return to a role where he served for eight years under President Barack Obama.


Under Secretary Vilsack's leadership, the United States Department of Agriculture (USDA) is building back better by restoring the American economy, strengthening rural and historically underserved communities, responding to threats of climate change, creating good-paying jobs for American workers and the next generation of agricultural leaders, and investing in our kids and our families.

Secretary Vilsack is spearheading a transformation of the food system by creating more, better, and fairer markets and ensuring the food system of today and the future is more resilient and more competitive globally. It will offer consumers affordable, nutritious food grown closer to home.

From excessive drought to more extreme fires, America's producers, farmers, and ranchers are on the frontlines confronting the challenges associated with climate change. The USDA is engaging the agriculture and forestry sectors in voluntary, incentive-based climate solutions to improve the resiliency of producers and to build wealth that stays in rural communities. Additionally, USDA is advancing investments in science and research to offer producers a toolbox to adapt to and mitigate climate change.

By working to ensure all aspects of civil rights and equity are integrated, the USDA is rooting out generations of systemic racism while building systems and programs inclusive of all USDA employees and customers.

Zach Ducheneaux





Administrator Farm Service Agency

Zach Ducheneaux was appointed administrator for United States Department of Agriculture's (USDA) Farm Service Agency on February 22, 2021. In this role, Ducheneaux provides leadership and direction on agricultural policy, administering loan programs, and managing conservation, commodity,

disaster, and farm mar-keting programs through a national network of offices. Ducheneaux previously served as the executive director of the Intertribal Agriculture Council (IAC) and had been with the IAC since the 1990s. He also previously served as tribal council rep-resentative for the Cheyenne River Sioux Tribe. He has spent his career educating people about the critical role of improved food systems, value-added agriculture, and foreign exports to respond to the enduring economic and social challenges facing Native Americans and reservations. Ducheneaux serves on the board of directors for Project H3LP!, a nonprofit founded by his family to benefit their local community by providing life lessons through horsemanship. His family still operates its fourth-generation ranch on the Cheyenne River Sioux Reservation.

Michael Regan





Environmental Protection Agency Administrator

Michael S. Regan was sworn in as the 16th administrator of the United States Environmental Protection Agency (EPA) on March 11, 2021, becoming the first black man and second person of color to lead the U.S. EPA.

Administrator Regan is a native of Goldsboro, North Carolina, where he developed a passion for the environment while hunting and fishing with his

father and grandfather, and exploring the vast lands, waters, and inner Coastal Plain of North Carolina.

As the son of two public servants -- his mother, a nurse for nearly 30 years, and his father, a retired colonel with the North Carolina National Guard, Vietnam veteran, and former agricultural extension agent -- Regan went on to follow in his parents' footsteps and pursue a life of public service.

Prior to his nomination as EPA administrator, Regan served as the secretary of the North Carolina Department of Environmental Quality (DEQ).

Previously, Administrator Regan served as associate vice president of U.S. Climate and Energy and as southeast regional director of the Environmental Defense Fund, where he convened energy companies, business leaders, environmental and industry groups, and elected officials across the country to achieve pragmatic solutions to the climate crisis.

He began his career with the U.S. EPA, eventually becoming a national program manager responsible for designing strategic solutions with industry and corporate stakeholders to reduce air pollution, improve energy efficiency, and address climate change.

Throughout his career, he has been guided by a belief in forming consensus, fostering an open dialogue rooted in respect for science and the law, and an understanding that environmental protection and economic prosperity go hand in hand.

Administrator Regan is a graduate of the North Carolina Agricultural & Technical State University, making him the first EPA administrator to have graduated from a historically black college and university. He earned a master's degree in public administration from the George Washington University.

He and his wife Melvina are proud parents to their son, Matthew.

Acting Director National Institute of Food and Agriculture

Dr. Dionne Toombs is the acting director of the National Institute of Food and Agriculture (NIFA), the U.S. Department of Agriculture's (USDA) extramural grant funding agency for agricultural research, education, and Extension programs.

Previously, Dr. Toombs served as director of the Office of the Chief Scientist (OCS), where she provided leadership on issues affecting science programs and science policy in agricultural research, education, and economics. She led activities of the OCS to strengthen science and science leadership, improve national coordination, and enhance outreach and awareness. Dr. Toombs has significantly contributed to USDA's agricultural research, education, and Extension services while serving in various leadership roles, including heading the Division of Nutrition at NIFA. Additionally, Dr. Toombs served as the national program leader (NPL) for NIFA's Agriculture Food and Research Initiative (AFRI), leading large competitive grant programs to fund research into nutrition, food science and technology, and food safety. Prior to serving as NPL, Dr. Toombs was a program specialist for food science and nutrition at the former USDA Cooperative State Research Education & Extension Service, now NIFA. Dr. Toombs earned her Ph.D. in nutritional sciences from Howard University, her master of science degree in food science from Alabama A&M University, and her bachelor of science degree in biology from Bethune-Cookman University.

She enjoys spending time with family, Pilates, participating in community service projects, and learning how to play golf.

Ted McKinney serves as the chief executive officer of NASDA, the National Association of State Departments of Agriculture, a position to which he was named in September 2021. Prior to NASDA, he also was the first U.S. Department of Agriculture (USDA) under secretary for trade and foreign agricultural affairs from 2017-2021. In that role, Under Secretary McKinney led the development and implementation of the department's trade policy, oversaw and facilitated foreign market access, and promoted opportunities for U.S. agriculture through various trade programs and high-level

government negotiations.

After his USDA service, McKinney was engaged in foreign affairs and outreach involving the U.S. food and agriculture industry and its engagement with the United Nations Food Systems Summits.

In 2014, McKinney was appointed by then-Governor Mike Pence to serve as director of the Indiana State Department of Agriculture, a position he held until joining USDA in 2017. His career also included 19 years with Dow AgroSciences, where he served in nearly all government and public affairs roles, and 14 years with Elanco, at that time a subsidiary of Eli Lilly and Company, where he was director of global corporate affairs. His industry and civic involvement is vast, including service as founder and co-chair of the National FFA Convention Local Organizing Committee, membership on the Indiana State Fair Commission, and Purdue College of Agriculture Dean's advisory council, as well as on the boards of directors of the International Food Information Council and the U.S. Meat Export Federation.

McKinney grew up on a family grain and livestock farm in Tipton, Indiana, and was a 10-year 4-H member and an Indiana state FFA officer. He graduated from Purdue University with a B.S. degree in agricultural economics in 1981, at which time he received the G.A. Ross Award as the outstanding university senior male graduate. In 2002, he was named a Purdue Agriculture Distinguished Alumnus and, in 2004, received an FFA Honorary American degree. He also has received the Sagamore of the Wabash Award from Indiana Governors Pence and Holcomb. He and his wife Julie have three children and six grandchildren; they reside in Alexandria, Virginia.



Gregg Doud brings an unparalleled global perspective and economic expertise to the team at Aimpoint Research. He works closely with members of the Executive Intelligence Network (EIN) and plays a major role in the development of its thought leadership priorities. Prior to joining Aimpoint, Doud served in the office of the U.S. Trade Representative as chief agricultural negotiator with the rank of U.S. Ambassador. He was one of the primary architects of the U.S.-China "Phase One" trade agreement.

Doud previously served as president of the Commodity Markets Council, the leading trade association for commodity futures exchanges and their industry counterparts, where he worked to lead the industry in addressing global market and risk management issues. As a senior staff member of the Senate Agriculture Committee, Doud helped craft the 2012 Senate Farm Bill, working on international trade, food aid, livestock, and oversight of the Commodity Futures Trading Commission. Doud served as chief economist for the National Cattlemen's Beef Association for eight years and is a former market analyst for the U.S. Wheat Associates.

Raised on a dry-land wheat, grain sorghum, soybean, swine, and cow-calf operation near Mankato in north-central Kansas, Doud continues to be involved in his family's 100-year-old farm and is a partner in a commercial cow-calf operation. He received a B.S. in agriculture with an emphasis in animal science as well as a M.S. in agricultural economics from Kansas State University. He currently resides with his family on their horse farm in Lothian, Maryland.



3:15 p.m. The Impact of Renewable Energy to the Nation's Security Vice Admiral Dennis V. McGinn, USN (Ret)

Center for Climate & Security Advisory Board member



Admiral Dennis McGinn served as assistant secretary of the Navy for energy, installations, and environment from September 2013 until January 2017. In this role, he led the transformation of naval installations toward greater mission resiliency though energy efficiency, renewable energy, microgrids, and other technologies.

Previously, Admiral McGinn served on active duty in the United States Navy for 35 years, attaining the rank of vice admiral. He also served as deputy chief of naval operations for warfare requirements and programs, overseeing the

development of future Navy capabilities, and previously commanded the United States Third Fleet. While in the Navy, he served as a naval aviator, test pilot, aircraft carrier commanding officer, and national security strategist.

Admiral McGinn is a former president of the American Council on Renewable Energy (ACORE), where he led efforts to communicate the economic, security, and environmental benefits of renewable energy. Admiral McGinn is a past member of the steering committee of the Energy Future Coalition Bipartisan Center Energy Board and co-chairman of the CNA Military Advisory Board.
