## **Position Description**

The Division of Applied Social Sciences (DASS) seeks applications for the position of Instructor. This is a non-tenure track, nine-month appointment, which will support its undergraduate programs in Agricultural Education & Leadership and Science & Agricultural Communications.

This position will be responsible for teaching courses in science and agricultural communications (offered both semesters) and, specifically, Verbal Communications in Agriculture, Food and Natural Resources, which is offered both spring and fall, and serves more than 200 students each year. This position will also assist with undergraduate advising and student recruitment activities. Other teaching responsibilities may be assigned in place of the above should our needs change.

#### **Qualifications**

- Will have completed a graduate degree in a field related to the above described teaching assignment by Aug. 31, 2020, OR an undergraduate degree in a related field, plus a minimum of five years' experience in a closely related field.
- Experience working with undergraduate students in a learning and mentoring environment is required.
- Experience with e-learning and technology-related educational innovation is required.
- Prior experience working with undergraduates for advising, recruitment, and industry connections is preferred.
